# 2025 Phillipsburg Rodeo Queen Contest Rules and Regulations

- 1. Single ladies between the ages of 16 and 25 are eligible. Age is determined as of the day of the contest. Ladies with children are not eligible to try out, and the winning queen must not marry or become pregnant for the entire year of reign.
- 2. If a contestant has been crowned at a prior contest, for this contest year (2025), she is ineligible to compete.
- 3. Contestants must conduct themselves in a proper lady-like manner, and remain friendly, helpful, and congenial at all times. Foul language or actions will not be tolerated.
- 4. Each contestant is required to submit a non-refundable \$35.00 entry fee/\$50.00 late entry fee made payable to the *Phillipsburg Rodeo Queen Committee*.
- 5. No stallions may be used as a contest horse. Contestant must ride the horse that she competes on for the parade and all Kansas' Biggest Rodeo performances. Horses must be sound and free of illness. If contestant is traveling from a state other than Kansas, a current Coggins test is also required.
- 6. Contestant must send application, entry fee, and a non-returnable head and shoulders photograph (5x7) of herself postmarked by July 5, 2025. Application postmarked after July 5, 2025 will be excepted, however will require a non-refundable \$50.00 late entry fee. All proper documentation must be received by July 16, 2025 11:59 pm CST. Please make sure ALL proper documentation and fee is submitted! Entry fees will be waived for contestants who competed but did not receive the title in the year immediately prior to the current year's competition. Those contestants who competed and did not receive the title in 2024, will not be required to submit an entry fee for 2025. However, all other documentation must be submitted within the dates listed above.
- 7. Contestants must have a signed waiver of liability before the contest.
- 8. Contestants must be at contest site 30 minutes before the contest begins and must check in with a committee member upon arrival. Due to time constraints, horses should be saddled and ready prior to the start of the contest. Phillipsburg Rodeo Queen Committee members are Heather McClain and Joni Hilburn. The contest begins at 9:00 a.m. at the Phillips County Fair Building, Wednesday, July 30, 2025.
- 9. Stalling facilities are available upon request to contestants needing to stall their horses overnight. All requests should be contacted to a PRQ committee member at least one week prior to the contest date.
- 10. Due to limited availability, if hotel accommodations are needed, it is recommended to book reservations several months in advance at any of the following locations in Phillipsburg: Cottonwood Inn, Rodeway Inn, or Econo Lodge.
- 11. The order of the contest will be determined by the committee and will be strictly adhered to throughout the contest.
- 12. Judges' decisions are final! Any suggestions or complaints must be made to the committee only. No contestant or family/friends/helpers of a contestant are to approach the judges in any negative form or manner.
- 13. All scores will be submitted to a Certified Public Accountant following the event. Each contestant will receive her individual score sheets by mail following the contest.
- 14. In the event of a tie, the contestant with the highest horsemanship score will receive the higher ranking. If a tie still remains, the final score from Judge # 1 will be used to determine the winner. A tie for Miss Congeniality will be broken by a silent judge appointed by the Phillipsburg Rodeo Queen committee.
- 15. If the competition consists of only one single contestant, that contestant must receive a minimum total score of at least 50% of the total points possible to receive the title.

- 16. Awards will be presented to the newly crowned queen, including a traveling crown, sash, saddle, and belt buckle. All contestants will be awarded various prizes.
- 17. A dress code will be strictly enforced. No crop-tops, tee shirts, shorts or exposed belly buttons will be allowed while riding in the Queen, Runner-up, or Contestant positions. Anytime the queen or contestants are representing Kansas' Biggest Rodeo, or the contest itself, they shall be attired in long-sleeve blouses with tails tucked in and appropriate pants/jeans. If you have any questions in regard to this rule, please contact a committee member. This rule applies to the reigning queen throughout the year.

# **Obligations and Additional Guidelines**

- 1. As the ambassador of Kansas' Biggest Rodeo, the queen must ride in the grand entry at each night's rodeo performances July 31 August 2, 2025. The queen, in the past years, has also been allowed to help carry sponsor flags/pen calves back during the rodeo. The queen must converse with the out-going queen for tips and instructions pertaining to carrying flags/penning back calves. (Note: Queens are unfortunately not always allowed to carry flags/pen back calves each year. Should this situation occur, the queen may either stay mounted to cheer on fellow contestants outside the arena or may relate/visit with spectators amongst the crowd.) The queen must also attend breakfast with the out-going queen, the KKAN/KQMA radio live broadcast, official photo shoot, and Meet and Greet sponsored by American Family Insurance Friday, August 1, 2025. (Note: If time allows, the queen will also meet that day with various local sponsors.) The Phillipsburg Rodeo Queen must also ride in the rodeo parade Saturday, August 2, 2025. All queen contestants are encouraged and welcome to ride in the parade along with the newly crowned queen.
- 2. During her title year, the Phillipsburg Rodeo Queen is obligated/required to the following:
  - Attend the 2026 Miss Rodeo Kansas Coronation. (Tentative Date: January/February 2026)
  - Attend the 2026 Phillips County Fair to greet the public and sign autograph sheets. (Tentative Date: Last week/weekend of July)
  - Attend all possible rodeo and social functions to represent Phillipsburg Rodeo Queen and Kansas' Biggest Rodeo. A minimum of FIVE rodeo/parade appearances are required, along with a minimum of TWO community appearances are also required. Examples of community appearances include nursing homes, libraries, schools, concession stands, community events, etc.
  - Establish and maintain the Phillipsburg Rodeo Queen 2025 Facebook page. (The queen must converse with the out-going queen for tips and instructions pertaining to the Facebook page)
  - Return to visit ALL sponsors and obtain funds and prizes for the next year's contest. The queen is obligated to recruit new sponsors. All sponsors must be met, and funds obtained by May 1, 2026. The buckle must be purchased no later than May 1, 2026.
  - Return to help organize, assist, and set horsemanship pattern in next year's contest and conduct promotional radio ads.
  - Attend one night of the Kansas' Biggest Rodeo slack performances to help serve in concession stands.
  - Attend the first night of the next year's Kansas' Biggest Rodeo performance. (This will be the FINAL recognition and representation as the 2025 Phillipsburg Rodeo Queen. The newly crowned 2026 Phillipsburg Rodeo Queen will carry out the remaining queen duties of the rodeo performances, appearances, etc. However, along with the committee, she will remain available if needed to guide and help the newly crowned queen during the remainder of the rodeo performances, appearances, etc.)

During her title year, although not required, the Phillipsburg Rodeo Queen is encouraged to attend the following:

- Attend the 2025 Phillips County Ranch Rodeo (Tentative Date: August 16, 2025)
- Attend the 2026 Phillipsburg High School Rodeo (Tentative Date: TBD)
- Attend the Appreciation Supper sponsored by the Phillipsburg Rodeo Committee. (Event Pending)
- Attend any Phillipsburg Chamber and Main Street Event/s. (TBA)
- 3. Portions of the funds regarding the travel budget will be dispersed to the queen immediately following the next year's final performance of Kansas' Biggest Rodeo. A maximum dispersal of \$300 will be provided for travel expenses. An additional performance bonus may also be awarded for meeting specific criteria set forth by the committee. Funds may be withheld by the Phillipsburg Rodeo Queen committee shall there be any misconduct or failure to meet all required queen rules and obligations.
- 4. All published documentation (letters, flyers, etc.) regarding the Phillipsburg Rodeo Queen organization must be submitted to the Phillipsburg Rodeo Queen committee for approval prior to publication.
- 5. Along with all rodeo and community events, the queen is also required to wear queen attire (crown, sash, and buckle) while recruiting sponsors and during her duties during the next year's contest.

- 6. Regarding the Phillipsburg Rodeo Queen flag and the chaps: The flag MUST be folded and kept in storage while not in use. It is important to keep the flag clean and soil free. This rule also applies to the chaps. Professional clean only. If cleaning is needed, contact a committee member. The flag must be treated with respect at all times. The current queen may choose an escort to ride behind her and carry the flag in a parade if she chooses, or she can carry the flag herself. If she chooses to have an escort, that person must follow the above dress code. Remember, you and your escorts and attendants are representing Kansas' Biggest Rodeo!
- 7. The queen is urged to ride in as many parades and rodeo events as possible to promote Kansas' Biggest Rodeo. The queen is expected to be friendly, helpful, and congenial at all times. No foul language or actions, criminal offenses, acts of promiscuity, or un-lady-like behavior will be tolerated. Remember, this is a **PRIVILEGE**, and you are an **EXAMPLE** to future contestants and queens preceding you. A great attitude is everything!
- 8. Any exceptions to the conditions listed above must come before the Phillipsburg Rodeo Queen Committee for approval. Any absences to these events or any misconduct shall constitute grounds for a majority vote of the committee. This majority vote shall determine if the queen's obligations have been breached. If the committee votes that she has not fulfilled her obligations, the queen must forfeit her crown, sash, buckle and ALL prizes and monies to the first runner-up, who will complete the year's obligations.

#### **Order of Events**

Check-in will take place Wednesday, July 30, 2025 at 8:30 am, with the contest beginning at 9:00 am.

### Wednesday, July 30, 2025

Phase I (held at Phillips County Fair Building) South Entrance along HWY 183

#### Modeling

- Contestants will model a western outfit of their choice (dress, suit, rodeo arena queen attire, etc.) Though any western outfit is acceptable, a fashion forward western dress is most preferred.

#### Speech

- Contestants will deliver a 2-4 minute speech relating to anything with a western theme.
- Penalties for not meeting or exceeding speech time will be at each judge's discretion.

#### **Public Interview**

- Contestants will answer a variety of personality/current event/equine/rodeo questions.

#### Written Test

The test will include questions relevant to the equine industry, Professional Rodeo Cowboys Association, Kansas' Biggest Rodeo, and Miss Rodeo America organization.

#### Personal Interview (Closed to the public)

- Each judge will ask current event/equine/rodeo questions of his or her choice, along with informal conversation to better familiarize with each contestant.

#### **Photogenics**

- Judges will individually review entry photos. (Judges only)
- \* Contestants will wear the modeling outfit of her choice for all events of Phase I.
- \* Each contestant will be given 30 minutes to transition between Phase I and Phase II.

#### Phase II (held at KBR arena) North Entrance along HWY 183

#### Horsemanship Round 1

- Contestants shall wear unique and eye-appealing rodeo queen riding attire of their choice.
- Contestants will perform a working cow horse pattern with their own horse.
- After pattern is complete, contestants then will execute a mount/dismount in front of the judging panel, followed by a queen's run **AND** flag run before exiting arena.

#### Horsemanship Round 2

- Contestants shall wear unique and eye-appealing rodeo queen riding attire of their choice.
- Contestants will perform rail work with a horse of another contestant drawn by the contestant.
- All tack will remain with the original horse to provide proper comfort to the horse during horse exchange. Contestants
  may adjust stirrup length as needed. Exceptions may only be initiated by the committee.
- After rail work is complete, contestants will be dismissed to exit arena.

#### **Coronation Rehearsal**

- Contestants and outgoing queen will practice coronation rehearsal with committee.

#### **Final Decision**

- Judges will individually review scores and acknowledge the contestant they feel should be crowned as the new Phillipsburg Rodeo Queen. That contestant will then receive the final decision points. Only one contestant per judge will be given these points. (Judges only)
- \* In all rounds of horsemanship, horses shall be ridden with western saddles and split reins. Spurs may be used with caution, however tie-downs or any other training aid will not be permitted.
- \* Contestants shall wear the same rodeo queen attire/outfit for both rounds of horsemanship.
- \* Hats must stay in place for the contest and ALL riding appearances. Pins, hair spray, tape, etc. are strongly encouraged.

#### **Phase III**

#### **Queen Luncheon**

- A luncheon will be held at the Pizza Hut in Phillipsburg immediately following Phase II of the contest.
- Contestants shall wear queen attire of their choice.
- All contestants are required to attend. Judges, committee members, family, and friends are also welcomed to attend. Only meal prices of contestants, judges, and committee members are covered.

#### **Group Photo**

- All contestants are required to meet for an official group photo. (Destination TBA)

#### **Sponsor Visits**

- Contestants will meet with various local sponsors to show appreciation for their contributions throughout the year. (Travel arrangements provided)
- \* Phase III will conclude once sponsor visits are completed. Contestants will be released by 5:00 pm.

## Thursday, July 31, 2025

#### Coronation (held at KBR arena)

- Coronation will be held prior to the rodeo performances Thursday, July 31, 2025 at 6:45 pm. (Exact times may vary.) All contestants must be lined up 30 minutes prior to coronation.
- Following coronation, ALL contestants are required to ride in the grand entry prior to the night's rodeo performance.
- All contestants will receive prizes donated by various sponsors. Prizes must be picked up IMMEDIATELY following coronation.
